Terms of Use

Thank you for your purchasing the ABLE Hakuba Goryu & Hakuba47 Season Pass by purchasing the pass, You agree to abide by the following Terms of Use.

- (1) Any unauthorized use of this pass shall result in it being immediate rescinded.
- (2) This pass may only be used by the purchaser of the pass as shown in the attached photograph. The pass may not be used by any other person, for any reason whatsoever. Failure to abide by this rule will result in the pass being immediately rescinded as per (1) above. If any misapplications involved, a fine that values of days of improper use x One Day Pass shall also be charged.
- (3) Should you transfer the pass to another individual, it is prohibited to purchase the Able Hakuba Goryu & Hakuba47 and Goryu Night Skiing Season Pass for 10 consecutive seasons from the season following the purchase.
- (4) Individual ski areas establish regulations regarding the use of their slopes, including prohibitions on off-course skiing. Pass holders are expected to obey these regulations. Failure to abide by these regulations will result in the pass being immediately rescinded as per (1) above.
- (5) Deliberate tampering or modification of the case containing the IC card will disable the IC card. Such attempts will result in the pass being immediately rescinded as per (1) above. If a member of the ski area staff asks to see your card in order to confirm your identity, you must show the card with the photograph clearly visible.
- (6) Please kindly note that once ABLE Hakuba Goryu & Hakuba 47 Common Season Passes are purchased, under no circumstances (including weather conditions) will refunds or cancellations be made. However, we will be providing refunds in accordance with Goryu & Hakuba 47 committee regulations if our operation period is limited to 10 days or less and also providing full refunds if we are forced to close our operations during the winter. Season Pass holders will be eligible for a refund on their season pass, from which handling fees are deducted.
- (7) The pass is valid from the first day the ski area opens until the last day of that same snow season. The Spring Pass is valid from March 1st until the last day of that same snow season.
- (8) This pass is not valid for usage that requires extra charges, such as night skiing.
- (9) Should you lose the pass, immediately contact the ski area where you purchased the pass.
- (10) The pass is valid from the first day the ski area opens until the last day of that same snow season. However, even on operating days, the ski area may close some or all of the slopes and lifts due to inclement weather or snow conditions. As well, lifts may cease operation for a number of reasons before the end of the season. Pass holders are urged to confirm that lifts are operating by phone or the Internet before traveling to the ski area.
- (11) The deposit is required only for Grand Senior and Kids Pass.

Handling of Personal Information

In accordance with the April 1st, 2005 full-scale implementation of the Act on the Protection of Personal Information, the ABLE Hakuba Goryu & Hakuba47 Ropeway Council resolves to handle the personal information of those who purchase Area Season Passes with due care and in accordance with personal information laws, regulations, and cabinet minister guidelines, and protect the privacy of that information while using it for the following purposes.

- To determine the identity of customers applying for and purchasing Area Season Passes.
- To deliver information, text, and so on regarding the use of the Area Season Passes.
- To deliver other information and messages.
- To inform customers who purchased Area Season Pass about special events and services planned and organized for purchasers by the ABLE Hakuba Goryu & Hakuba47 Ropeway Council.

The handling of personal information may be entrusted to third parties, but in those cases, care will be taken to maintain sufficient security levels to protect personal information, and the appropriate and necessary oversight will be undertaken.
